- The HULFT Logos are the Company's valuable brand property and the Authorized Partner shall use the HULFT Logos in compliance with these Guidelines at its responsibility, paying sufficient attention to maintaining and enhancing the asset value thereof when using the HULFT Logos.

1 Type of HULFT Logos

The HULFT Logos are classified into the following two (2) categories:

1) Product Logos

Logos defined for each product to enhance the recognition of product brands.

2) Authorized Partner Logos

Logos defined to enhance the recognition of the Authorized Partner's skill and competency.

O Use of Product Logos

The Authorized Partners may use the product logos corresponding to their products in accordance with these Guidelines.

Use of Authorized Partner Logos

The Authorized Partners may use the Authorized Partner logos corresponding to their own category and level.

04 Ownership of Rights




07 Prohibitions



10 Minimum Available Size

11 Spaces

Spaces are required between the HULFT Logos and other elements.

Assuming that the vertical size of the HULFT Logo is "a," please leave a space of "0.5a" above and below the HULFT Logo, and a space of "0.3a" at the left and right sides of the HULFT Logo.



Do not place any other elements (characters or designs) within such space.

17 Revision of Guidelines

- 1) The Company may revise these Guidelines anytime, at its discretion. In such event, the revised version of these Guidelines shall apply to the Authorized Partners' right to use the HULFT Logos and any and all matters related to these Guidelines as from the date of revision thereof by the Company, and the Authorized Partners agree to the above.
